Dear Parents and Guardians of MSA students,

Tuition for the 2023/2024 School Year

As part of the annual budgeting process, the Board of Governors (the "Board") of Mount Saint Agnes Academy ("MSA") has conducted a thorough review of school resources and expenses for the upcoming academic year.

The Board is very sensitive to the ongoing economic difficulties being experienced by some of our parents and guardians of students at the school which is reflective of economic conditions of Bermuda as a whole. Keeping the increase in tuition to an absolute minimum and providing support to families who are struggling to pay tuition are key priorities of the Board.

The high levels of worldwide inflation have had a significant impact on the living costs in Bermuda. These challenging conditions have also had a negative impact on MSA, in particular, increased operating costs and decreased donations. While the school does receive some financial support from the tremendous fundraising initiatives of its Home & School Association and the Bazaar Committee, as well as the individual generosity of friends and family of the school, tuition fee income remains, by far, the principal source of income to cover the school's expenses.

Taking the increasing costs of the school's needs into account but keeping the current economic conditions in mind, the Board is focused on keeping the annual fee increases to a minimum. Following the annual budgeting process, the tuition fees for the next academic year have been set as follows:

Grades K to 12	\$20,510
Early Learning Program	\$13,500

The tuition fees above represent a 2.75% increase compared to the prior year. The school's largest expense category is salaries and benefits of our teachers. The Board is extremely grateful for the dedication of our faculty and staff who go above and beyond to ensure our students receive the best possible education. When completing the annual budgeting process, the Board ensures that the salaries are fair and reflective of the increased cost of living in Bermuda.

The Board is committed to providing excellence in private Catholic education, in a caring, Christian environment through the delivery of MSA's internationally recognized curriculum. Our commitment to provide excellent learning resources and instruction in an exceptional school environment includes the following:

- continued investment in technology to ensure we meet the requirements of our leading education curriculum. Our 1-to-1 student laptop program has been completed and all middle and high school students are now equipped with their own laptop. Elementary students have also benefited from this program, as the availability of laptops has increased substantially for their use. There is continued focus on infrastructure improvements and equipment maintenance, a significant expense to the school.
- ongoing professional development, including Kagan training to all staff and continued coaching with Alberta curriculum specialists to support optimum student learning and improved student performance.
- continued engagement of Solstice, a holistic wellness center, to ensure all students have access to the mental health support they need for their physical, emotional, and spiritual well-being.
- expanding our Early Learning Program (ELP) from one class to two classes this September. Increasing the student enrollment for ELP will help to increase the class sizes of our elementary grades in the upcoming years. Increased enrollment is essential to allow for better facilities, more option classes and increased extracurricular activities.
- ongoing facility upgrades and maintenance to ensure an effective and safe learning environment.

The Board recognizes that any rise in expenses, even from something as important as your child's education, may cause financial challenges. If you expect any difficulties with the payment terms outlined at the end of this letter, please contact our Business Manager to discuss your tuition payment options.

Finally, the Board would like to take this opportunity to thank the many parents and guardians who volunteer their time and talents to support MSA. These fundraising and volunteer efforts play a large role in keeping tuition fees as low as possible, and within this extremely challenging financial environment, these efforts are valued more than ever. Payment of fees can be done via three payment options (see below chart for details):

- Monthly from August 21, 2023, through to May 31, 2024
- Three installments, August 21, 2023; December 1, 2023 & March 1, 2024 (3% discount if paid by due dates)
- Annually by August 21, 2023 (5% discount if paid by due date)

Other charges for the year include:

- Resource fee of \$300 for students in grades K to 12 (included in chart below)
- Technology fee of \$200 for students in grades 6 to 12 (included in chart below)
- Yearbook fee of \$75 for students in grades K to 12 (not included in chart below) If you do not wish a yearbook, written notice must be provided to the Business Manager by December 1, 2023, to avoid the charge.
